



## **Rural Affairs Department (RAD) - Security Policy for access to CCTV footage**

### Scope

In line with the CCTV Surveillance Cameras Policy for the Rural Affairs Department (RAD) the scope of this policy is to outline and undertake the procedure implemented with regards to requests of access to CCTV by any individual or entity which for a specific reason would need such data. Any internal access to visual images by the Rural Affairs Department or any disclosure of such images further to a request by a law enforcement authority or by the data subject shall be logged and kept as evidence.

### Request for CCTV footage

All forms submitted must be sent via email to RAD's data protection officer at [dataprotectionrad.mafa@gov.mt](mailto:dataprotectionrad.mafa@gov.mt). RAD CCTV footage has a retention period of **7 days**, therefore one needs to submit the request within the **7 days** of the incident to allow for such request to be processed in time.

**Note: RAD must be satisfied that all requests are genuine and that persons making a request understand their legal obligations in relation to possessing and making use of images recorded on the RAD's CCTV system.**

When submitting a request, one should also be aware that the copyright of all images remains with RAD and images may not be published or otherwise shown without specific written permission from RAD.
